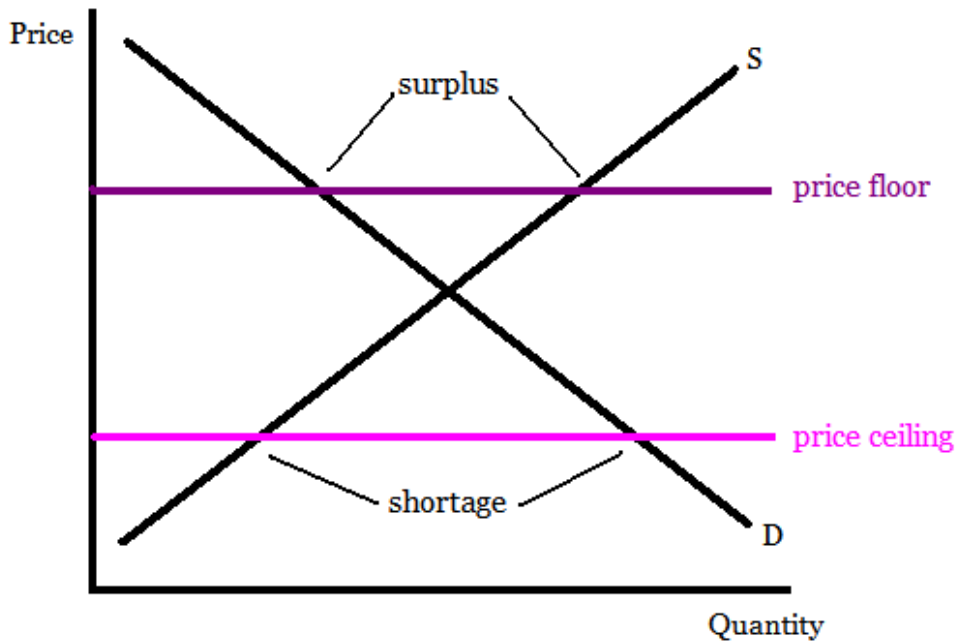


How Government Policies Can Affect Demand and Supply
